**PETITION FOR APPOINTMENT OF GUARDIAN OVER
PERSON AND ESTATE OF INCAPACITATED PERSON**

Comes now Mary B. Kobek, who being duly sworn upon her oath, petitions the Court as follows:

1. That the alleged incapacitated person is a female _____ years of age presently residing at _____, in the City of Rensselaer, State of Indiana, County of Jasper.

2. That Martha E. Ham is unable to maintain and care for her financial affairs and person because she suffers from _____.

3. That the alleged incapacitated person owns personal property somewhere in the amount of _____ Dollars (\$ _____), said property includes her personal effects and social security income.

4. That the alleged incapacitated person has a life estate in real property located in _____ County, Indiana, and having the following legal description, to-wit:

5. That the alleged incapacitated person has a monthly income of approximately _____ Dollars (\$ _____). This income includes social security benefits.

6. That the petitioners do not seek any limitations on their guardianship appointment.

7. That there is no guardian of either the person or the estate appointed for the alleged incapacitated person in this state or in any other state, and there are no proceedings pending to the petitioner's knowledge.

8. That the petitioner is an adult, Mary B. Kobek, residing at _____, in Rensselaer, Indiana, who is the sister of the alleged incapacitated person.

9. That the names and addresses of the persons most closely related by blood or marriage to the alleged incapacitated person are:

10. That the institution having the care and custody of said Martha E. Ham is _____, located at _____, _____, _____.

11. That the petitioner herein, Mary B. Kobek, is not the legally appointed guardian of any other person or persons in this or any other state.

12. That the need exists for the appointment of a guardian of the person and estate of Martha E. Ham, in that she cannot handle her financial affairs and the assets of said Martha E. Ham need to be preserved for her support, maintenance, care, and proper medical treatment. The petitioner herein is interested in this appointment because she is one of Martha E. Ham's closest relatives.

13. That the petitioner believes a hearing on this matter would be advisable as soon as adequate notice can be given pursuant to I.C. 29-3-6-1 and I.C. 29-3-6-2 to all parties and persons directed by the Court to receive notice, and the petitioners request the Court set a hearing on this matter as soon as possible, consistent with providing the alleged incapacitated person and other interested persons with adequate notice.

14. That the name and address of the attorney representing said guardian is Ned J. Tonner, 203 North Cullen Street, Rensselaer, Indiana 47978, (219) 866-8888, Attorney No. 11345-45.

WHEREFORE, petitioner prays the Court to enter an order:

1. Setting a hearing on this petition as soon as possible consistent with the preservation of the rights of the alleged incapacitated person.
2. Requiring tht all necessary parties and persons be given adequate noticeof the guardianship proceedings.
3. After hearing, adjudicate that Martha A. Ham is an incapacited person.
4. Finding that guardian of the person and estate of Martha A. Ham needs to be appointed.
5. Finding that the petitioner, Mary B. Kobek, is a suitable person to be appointed guardian of the person and estate of Martha E. Ham.
6. Appointing Mary B. Kobek as guardian of the person and estate of Martha E. Ham to set out the duties and powers of the guardian.
7. And for all other relief which is proper in the premises.
