**ORDER APPOINTING GUARDIAN OVER THE
PERSON OF AN INCAPACITATED PERSON**

Comes now Kyle S. Hamilton, having filed her Petition for a Modification of the Order entered on February 20, 2001, which petition is on file with this Court and a part of the Court's record.

And the Court having reviewed the petition and being fully advised in the premises now finds that the allegations contained in the petition are true, and:

1. That Martha E. Ham is in need of a guardian of the person because of her incapacity and it is in the best interest of Martha E. Ham that a guardian be appointed over her person.

2. That Kyle S. Hamilton is a suitable person to serve as Guardian and is fully qualified and willing to assume the duties and responsibilities of the Guardianship of the Person of Martha E. Ham.

3. That all of the requirements for the appointment of a guardian as set forth in the Indiana Code have been satisfied and Kyle S. Hamilton is entitled to be Guardian of the Person of Martha E. Ham and is so appointed without any limitations as to her duties and responsibilities or powers.


4. That the Court pursuant to statute hereby finds that it was unnecessary to appoint Kyle S. Hamilton Guardian of the Estate of Martha E. Ham.

5. That the Court further finds that it is unnecessary for Kyle S. Hamilton to post a bond in the amount of Two Hundred Thousand Dollars (\$200,000.00).

It is therefore *ORDERED, ADJUDGED & DECREED* by the Court that:

1. Martha E. Ham by reason of her incapacity is unable to care for her person and is therefore adjudicated to be an incapacitated person, and a guardian over her person is necessary.
2. Kyle S. Hamilton is the most qualified and suitable person available to serve as guardian and is hereby appointed as the guardian of the person of Martha E. Ham.
3. Kyle S. Hamilton shall serve as guardian of the person upon taking an oath.
4. This Court's Order of February 20, 2001 appointing Kyle S. Hamilton as Guardian of the Estate is hereby vacated.
5. That further the Order of February 20, 2001 requiring the posting of a bond by Kyle S. Hamilton is hereby vacated.

All of which is **ORDERED** this 7th day of March, 2001.
