
TRUSTEE'S FINAL ACCOUNT AND PETITION
TO SETTLE AND ALLOW ACCOUNT AND FOR AUTHORITY
TO DISTRIBUTE TRUST CORPUS AND CLOSE TRUST.

Comes now Richard F. Comingore, as trustee of the Martha E. Ham Revocable Trust Dated September 11, 2000 and files his verified Final Accounting and Petition To Settle and Allow Account and for Authority to Distribute Trust Corpus, and respectfully shows the Court as follows:

1. That on or about August 23, 2002 , Richard F. Comingore, Attorney at Law was duly appointed and qualified as the trustee of the Martha E. Ham Revocable Trust dated September 11, 2000 and that he has continued to serve in such capacity to date.
2. That all the provisions established by the Martha E. Ham Revocable Trust dated September 11, 2000 have been discharged, except making final distribution to the beneficiary.
3. That all of the assets of the trust corpus have properly been administered upon and all obligations of the trustee have been discharged, except as to making of final distribtuion of the remaining assets being held in the trust estate. That there is no advantage to holding such funds in trust and it would be in the best interests of the beneficiary and the trust estate to distribute the same. The trustee knows of no reason why this trust estate cannot or should not be closed at this time and sets forth his final accounting as per Schedules A, B, C, D and associated Exhibits attached heretofore and made part and parcel hereof.
4. That the name and post office address of said income beneficiary of the trust estate as designated in Item III, Section 3 of the trust are as follows: Kyle Shayna Hamilton, 5237 Wiseburn Avenue, Hawthorne, CA 90250.
5. That the trustee requests compensation for his services rendered as trustee under this Trust Agreement for the following time period: February 1, 2003 to April 1, 2004. That the trustee rendered the following services: See attached Exhibit D and has approximately 88 hours devoted to the legal and administrative aspects of this trust. That the trustee requests compensation in the amount of One Hundred Twenty-five Dollars (\$125.00) per hour, wherein the trustee requests final compensation in the total amount of Ten Thousand, Nine Hundred Eighty-One and 75/100 Dollars (\$10,981.75).


